**REGULATION  
ON THE HOLDING  
OF THE II INTERNATIONAL OLYMPIAD  
ON STRATEGIC MANAGEMENT**

Ufa 2024

## I. GENERAL REGULATIONS

1.1. This Regulation defines the procedure for organizing, conducting and summarizing the results of the II International Olympiad on Strategic Management among students of schools, colleges and universities (hereinafter referred to as the Olympiad) using the computer business game «Business Course: MAXIMUM».

1.2. The organizers of the Olympiad are the Committee of the Republic of Bashkortostan for UNESCO (hereinafter the Committee), the UNEVOC Center in the Russian Federation (hereinafter the Center), the Bashkir Institute of Social Technologies (branch of) EUP VO «ATiSO».

1.3. The general management, control over the Olympiad, information and methodological support is carried out by the Organizing Committee, which develops the Regulations, approves the terms and procedure for the Olympiad, determines the winners and organizes their awarding.

1.4. The organizers of the Competition reserve the right to make changes to the regulations of this event.

## II. The purpose and objectives of the Olympiad

2.1. **The purpose** of the Olympiad is the formation of economic culture and modern economic thinking among schoolchildren and students.

2.2. **Tasks** of the Olympiad:

2.2.1. *Cognitive task*: definition of the quality and level of training of students in the field of economics and entrepreneurship.

2.2.2. *Developing task*: formation of analytical thinking, development of creative abilities, and professional orientation of participants.

2.2.3. *Personal task*: formation of personal qualities and communication skills of the younger generation.

## III. Participants

3.1. Students of grades 9 and 11, junior and senior students of colleges and Universities of Russia and foreign countries may take part in the Olympiad.

3.2. Participation in the Olympiad is a team event. The team must include no more than three participants. The educational institution carries out the formation of the team members independently. The educational institution can provide several teams.

#### **IV. The organization and timing of the Olympiad**

4.1. The Olympiad is held in **offline** and **online forms**.

4.2. To participate in the Olympiad, one must submit an application by **November 27, 2024** (Appendix No. 1 – Application Form). Send the application by e-mail: [kafedra.economiki.it@mail.ru](mailto:kafedra.economiki.it@mail.ru).

4.3. After confirmation of registration, participants receive instructions on how to complete the game by e-mail (specified in the application).

4.4. The Olympiad will be held on **November 29, 2024** at 10.00 a.m.

The registration of offline participants begins at 9.30 a.m.

The Olympiad will be held at the address: Ufa, Prospekt Oktyabrya, 74/2. Bashkir Institute of Social Technologies (branch of) EUP VO «Academy of Labor and Social Relations» (bus stop «Railway Hospital»).

4.5. The Olympiad in online form takes place through remote access to a computer. The head or supervisor of the team(s) from the educational institution receives instructions by e-mail to connect the computers of the educational institution to remote access.

4.6. The summing up and awarding of the winners will take place on **November 30, 2024**.

4.6.1. The pass is a team one. The place is determined according to the rating scored by the participating teams during the Olympiad and recorded by the computer program.

4.6.2. The winners of the Olympiad are awarded with diplomas.

4.6.3. All participants receive electronic certificates.

4.6.4. The team leader or supervisor receives Letter of Thanks.

5.1. The registration fee for participation in the Olympiad by Russian participants is 250 rubles (send the payment receipt along with the registration form on e-mail: [kafedra.economiki.it@mail.ru](mailto:kafedra.economiki.it@mail.ru)).
